CERTIFICATE OF INCORPORATION
OF
Harlem Launch Alliance Inc.

Under Section 402 of the Not-for-Profit Corporation Law

FIRST: The name of the corporation is: Harlem Launch Alliance Inc.

SECOND: Harlem Launch Alliance Inc. is a corporation as defined in subparagraph (5) of paragraph (a) of Section 102 of the Not-for-Profit Corporation Law.

THIRD: The purpose of purposes for which Harlem Launch Alliance Inc. is formed are as follows:

Harlem Launch Alliance Inc. will support amateur experimental aerospace research currently being conducted in New York City's Manhattan neighborhood of Harlem. Harlem Launch Alliance Inc. will make the results of its research and the progress of its experimentation available to the public in order to accelerate the pace of amateur rocketry research in the United States, specifically the east coast. In addition, the HLA will provide financial assistance to Harlem high school and college students who are preparing to, or are already, studying physics, chemistry, biology, mechanical, electrical or computer engineering, computer science, mathematics, or to those who have expressed an interest in working in the fields of aerospace or aeronautics.

FOURTH: Harlem Launch Alliance Inc. is not formed to engage in any activity or for any purpose requiring consent or approval of any state official, department, board, agency or other body. No consent or approval is required.

FIFTH: Harlem Launch Alliance Inc. is a charitable corporation under Section 201 of the Not-for-Profit Corporation Law.

SIXTH: The office of Harlem Launch Alliance Inc. is to be located in the County of New York, State of New York.

SEVENTH: The names and addresses of the three initial directors of Harlem Launch Alliance Inc. are:

EIGHTH: The Secretary of State is designated as agent of Harlem Launch Alliance Inc. upon whom process against it may be served. The address to which the Secretary of State shall mail a copy of any process accepted on behalf of Harlem Launch Alliance Inc. is:

5 Quaker Lane Farmingdale, NY 11735

NINTH: The following language relates to the Harlem Launch Alliance Inc.'s tax exempt status and is not a statement of purposes and powers. Consequently, this language does not expand or alter Harlem Launch Alliance Inc.'s purpose or powers set forth in paragraph THIRD.

No part of the net earnings of Harlem Launch Alliance Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that Harlem Launch Alliance Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article THIRD hereof.

Harlem Launch Alliance Inc. is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No substantial part of the activities of Harlem Launch Alliance Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and Harlem Launch Alliance Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, Harlem Launch Alliance Inc. shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of Harlem Launch Alliance Inc., after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
